

RESOLUTION NO. 1074

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF TERRELL, TEXAS, APPROVING THE COPIER MAINTENANCE AGREEMENT AND THE PRINTER MAINTENANCE AGREEMENT BETWEEN THE CITY OF TERRELL, TEXAS, AND SHARP BUSINESS SYSTEMS FOR THE MAINTENANCE OF COPIERS AND PRINTERS IN USE BY THE CITY OF TERRELL, TEXAS; AND A MUNICIPAL AGREEMENT BETWEEN THE CITY OF TERRELL, TEXAS, AND GREAT AMERICA FINANCIAL SERVICES CORPORATION FOR LEASE OF MULTIPLE COPIERS AND PRINTERS IN USE BY THE CITY OF TERRELL, TEXAS, AUTHORIZING THE CITY MANAGER OR HIS DESIGNEE TO NEGOTIATE AND EXECUTE THE AGREEMENTS WITH SHARP BUSINESS SYSTEMS AND GREAT AMERICA FINANCIAL SERVICES; AND ESTABLISHING AN EFFECTIVE DATE

WHEREAS, the City Council of the City of Terrell believes it to be in the best interest of the City to replace the current contract with ALPS/Xerox Corporation for the maintenance of the copiers and printers located throughout the City of Terrell; and

WHEREAS, Sharp Business Systems has submitted a proposal for maintenance of new copiers and printers to be used by the employees of the City of Terrell; and

WHEREAS, Great America Financial Services Corporation has provided a Lease Agreement for the lease of copiers and printers to the City of Terrell for a period of sixty (60) months; and

WHEREAS, the proposals from Sharp Business Systems and Great America Financial Services Corporation are in an amount not to exceed \$9,500.00 per month; and

WHEREAS, the City Council believes it to be in the best interest of the City of Terrell to enter into these Agreements based upon the recommendation of True North IT Services, LLC.

NOW THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF TERRELL, TEXAS THAT:

Section I.

That the Copier Maintenance Agreement between Sharp Business Systems and the City of Terrell for maintenance of the copiers for an overall term of sixty (60) months is in the best interest of the City with such monthly amount not to exceed \$1,600.00.

Section II.

That the Printer Maintenance Agreement between Sharp Business Systems and the City of Terrell for maintenance of the printers for an overall term of sixty (60) months is in the best interest of the City with such monthly amount not to exceed \$300.00.

Section III.

That the Lease Agreement between Great America Financial Services Corporation and the City of Terrell for lease of the copiers and printers for an overall term of sixty (60) months is in the best interest of the City with such monthly amount not to exceed \$7,600.00.


Section IV.

That the City Council authorizes the City Manager or his designee to negotiate and execute the Copier Maintenance Agreement, the Printer Maintenance Agreement between Sharp Business Systems and the City of Terrell and the Lease Agreement between Great America Financial Services Corporation and the City of Terrell as set forth herein.

Section V.

This Resolution shall be effective immediately after its passage.
